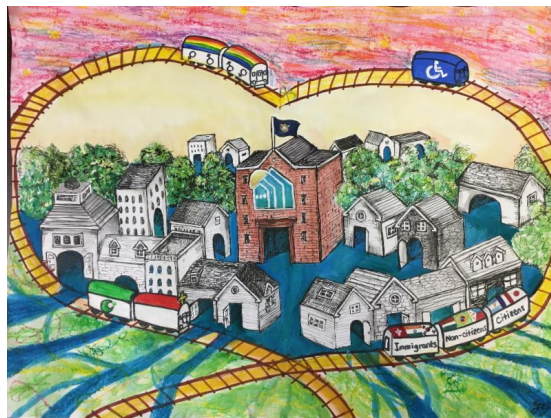

With your support, we can continue fighting for clients like Latisha.



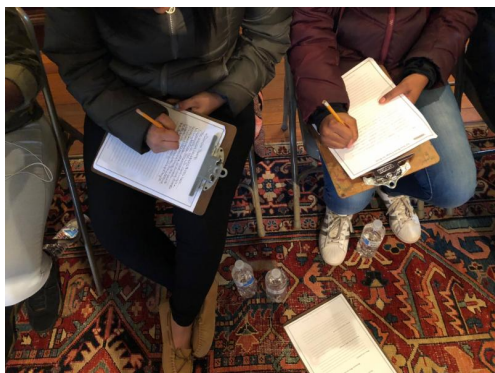
The Center worked to get Latisha and her son the [reasonable accommodation](#) they needed to move out of their mold- and insect-infested apartment after the conditions began to worsen her son's health issues. A former Marine, Latisha is a fierce advocate for her family, but her many attempts to resolve the issues on her own were ignored. Now, they're in a safe and clean new home, and Latisha says her son's symptoms have improved dramatically.

In addition to assisting thousands of individuals across the state in 2018, we also challenged [discriminatory systems and policies](#) which maintain Connecticut's high levels of segregation and inequality.

We took on modern-day [mortgage redlining](#) , [challenged a national tenant screening company](#) for discriminatory practices in a first-of-its-kind case, and joined a nationwide investigation and lawsuit which uncovered [a big bank's failure to maintain its properties](#) in communities of color in Connecticut and across the country.

We conducted systemic investigations of Connecticut's housing markets to assess the prevalence of housing discrimination against people of color, people with disabilities, families with children, and others protected by the fair housing laws. Our staff continued to lend their expertise on fair housing and lending issues to local, state, and federal officials.



Because education is key to preventing fair housing issues, this year the Center also [trained](#) more than 1,000 housing professionals, social service providers, tenants, [homeowners](#) , students, and public officials statewide on the fair housing laws and homeownership rights.
